



Medical Countermeasures Link Workshop: Federal Updates for State SNS and Local MCM Coordinators

INTRODUCTION

Public health emergencies can happen at any time, which means that health departments must be adequately prepared to respond. In some cases, medical countermeasures (MCMs) including



antibiotics, vaccines, medical equipment, and medical supplies must be rapidly deployed to ensure the preservation of health during an emergency. The CDC maintains the Strategic National Stockpile (SNS), which has huge quantities of MCMs available in times of crisis. Using guidance developed at the federal level, state, local, tribal, and territorial preparedness coordinators developed MCM response plans to ensure their jurisdictions receive potentially life-saving MCMs during emergencies. As new staff enter into MCM planning roles at health departments and as new MCM guidance and resources are continuously developed and updated, this MCM Link Workshop was created to share the most up-to-date MCM information to state, local, tribal, and territorial SNS/MCM coordinators.
