






Vaccination Status and Intent by **Demographics - United States**



Funding to States

Public Health Departments

- Awards ranging \$500,000 to \$50 million
- Period of performance 2 years
- COVID-19-related health disparities
- Advance health equity
 - Racial and ethnic minority groups
 - People living in rural areas

Funding to States (cont.)

- Immunization Programs




Vaccine Confidence Consults

- Total requests: 42
- Consults completed: 39
- Consults upcoming: 2
- Common themes
 - Government mistrust (28%)
 - Misinformation infertility (26%)
 - Strategies to improve communication/tailor messages to populations of focus (51%)
 - Vaccine safety concerns (31%)
 - Strategies to reach specific populations:
 Hispanic/Latinx (36%), African American (31%), Rural (23%), Youth (23%)
 - Interest in Rapid Community Assessment Guide (56%)
