#### SUMMARY

NACCHO's climate change program helps local health departments (LHDs) prepare for and respond to the health effects of climate change by developing strategies to improve climate change preparedness at the local level. NACCHO also provides expert opinion, analysis, and recommendations related to climate change.

#### HIGHLIGHTS

- NACCHO leads the Global Climate Change Workgroup, comprised of LHD officials and staff and related professionals.
- NACCHO is funding two local health departments to supplement their ongoing climate change and health adaptation initiatives in 2020.

#### SUMMARY

NACCHO's environmental public health tracking program provides strategies to strengthen collaboration and communication between state grantees and locals working to understand the links between key environmental health indicators (e.g., air quality, carbon monoxide, lead, water quality) and disease development.

#### HIGHLIGHTS

- NACCHO increases LHD participation in the National Environmental Public Health Tracking Network and seeks to improve relationships and communication with state and national efforts.

## Food Safety

### SUMMARY

NACCHO's food safety program supports LHDs by assessing the needs of their food safety programs, supporting them in foodborne disease outbreak response, and helping them implement continuous quality improvement programs.

### HIGHLIGHTS

- NACCHO runs a peer mentorship program for jurisdictions enrolled in the U.S. Food and Drug Administration's (FDA's) Voluntary National Retail Food Regulatory Program Standards.
- NACCHO's Food Safety Workgroup provides leadership and guidance to NACCHO, LHDs, and partner organizations regarding food safety efforts, health outcomes, and implications at the local level.
- NACCHO is a co-chair of the Council to Improve Foodborne Outbreak Response (CIFOR), working to improve methods to detect, investigate, control, and prevent foodborne disease outbreaks.
- NACCHO hosts a Foodborne Illness Outbreak Response Community of Practice.

## Health in All Policies

### SUMMARY

NACCHO's Health in All Policies (HiAP) program aims to increase awareness among decision makers and other stakeholders about the public health implications of policies and builds the capacity of LHDs to participate in cross-sector work to improve the health of the community.

### HIGHLIGHTS

- With partners, NACCHO offered a funding opportunity for jurisdictions to implement a HiAP strategy as part of their childhood lead prevention implementation program and activities.
- NACCHO is hosting a monthly HiAP webinar series in 2020.
- NACCHO provided technical assistance to 15 LHDs implementing HiAP.
- NACCHO created a HiAP policy map on NACCHO's HiAP webpage to show where state and local governments have adopted HiAP resolutions or executive orders.

## Healthy Community Design

### SUMMARY

NACCHO's healthy community design program strengthens the capacity of LHDs to participate in decision-making processes and extend their role in issues related to the built environment (e.g., land use planning and community design) to improve community health outcomes.

### HIGHLIGHTS

- In 2018, NACCHO began a new Creative Placemaking project with the Trust for Public Land, funded by the National Endowment for the Arts Our Town grant program, to conduct a literature review, convene a national steering committee of experts, develop a creative placemaking toolkit, and host a workshop at NACCHO Annual 2019.
- NACCHO funded over 20 LHDs to conduct health impact assessments on topics related to health and community design.
- NACCHO supports the Agency for Toxic Substances and Disease Registry's (ATSDR's) "Choose Safe Places" efforts to facilitate the promotion of resources and tools for ATSDR grantees and other health departments.
- NACCHO co-authored a publication with the University of Massachusetts and other partners published in January 2019 in the *Journal of Public Health Management and Practice: Developing Core Capabilities for Local Health Departments to Engage in Land Use and Transportation Decision Making for Active Transportation*.

### SUMMARY

NACCHO's vector control program supports LHDs in protecting their communities from the bacterial and viral diseases transmitted by mosquitoes, ticks, rodents, and other emerging vectors.

### HIGHLIGHTS

- NACCHO held the second annual Vector Summit for local vector control professionals in Pittsburgh in April 2019.
- The Vector Control Workgroup provides technical guidance on NACCHO projects, including the Vector Summits, policy statements, and Model Practices.
- NACCHO launched the Vector Control Collaborative, a funded peer mentorship program.
- NACCHO hosted two Vector Surveillance and Control Workshops in January 2019 to provide hands-on training and demonstrations to those serving hurricane-affected areas.

## Water

### SUMMARY

NACCHO's water program prepares local health officials for potable water-related emergencies, provides grants to local water facilities to update water fluoridation systems, and hosts bi-monthly webinars on recreational water health and safety.

### HIGHLIGHTS

- NACCHO runs the Model Aquatic Health Code (MAHC) Network, a community for MAHC users, subject matter experts, and those hoping to learn about the code itself. The network hosts bi-monthly webinars on a variety of topics related to the code.
- NACCHO's Water, Sanitation, and Hygiene (WASH) Emergency Preparedness and Response Workgroup is comprised of local health officials who have responded to a WASH-related emergency in the last five years. The workgroup meets on a monthly basis to discuss current needs and gaps in resources for LHDs responding to WASH emergencies.
