

NACCHO Intersectional Data Pathway Participatory Design Workshop:

Understanding LHD Needs at the Intersection of ACEs, SUD and Overdose Surveillance

OVERVIEW

In partnership with the Centers for Disease Control and Prevention (CDC), NACCHO is seeking local health department staff to provide feedback and input on the development of a data to action pathway for the intersection of adverse and positive childhood experiences (ACEs/PCEs), substance use disorder (SUD), and overdose via a 90-minute, participatory design workshop facilitated by Kahuina Consulting, LLC in May 2024. Each participating local health department will receive at least one scholarship for a livestream, virtual NACCHO 360 registration.

BACKGROUND

NACCHO has contracted with Kahuina Consulting, LLC to 1) identify local health departments' data to action needs at the intersection of adverse and positive childhood experiences (ACEs/PCEs), substance use disorders (SUD), and overdose and 2) develop guidance and resources to support LHDs' surveillance of ACEs, PCEs, SUD, and overdose and inform CDC/NACCHO's future project work.

Kahuina has drafted a surveillance framework for data to action at this intersection, which will be presented to LHD representatives for feedback and input in a 90-minute, virtual participatory design workshop. The data to action framework aims to provide a clear process that assists LHDs to better understand how to collect, access, and interpret data relevant to this intersection; identify gaps in available data; articulate and answer surveillance questions; and inform decision-making.

WHY PARTICIPATE?

Share your experience and expertise to inform the design of a data to action pathway that your team and other LHDs will actually use.

Connect with our local health departments across the country doing similar work.

Receive a scholarship for a livestream, virtual NACCHO 360 registration (at least one per LHD).

ELIGIBILITY

NACCHO is seeking group of participants with diverse jurisdictional characteristics for this project so that feedback on the pathway can represent multiple perspectives. **This opportunity is open to all city, county, and tribal health departments with:**

- Varying levels of experience working at the intersection of ACEs, PCEs, substance use, and/or overdose. **Participants do not need to have current programming that addresses the intersection but should have an understanding of the concept and an interest in pursuing an integrated approach to prevention.*
- Varying levels of surveillance capabilities and technology
- Experience collecting ACEs, PCEs, substance use, and/or overdose data
- Experience working with different data sources related to ACEs, PCEs, substance use, overdose, and/or shared risk and protective factors
- Experience collaborating with multi-sector organizations

PARTICIPANT EXPECTATIONS

May 2024

Virtual Introduction and Orientation Meeting

Participants will attend a **30-minute** virtual introduction and orientation meeting facilitated by Kahuina Consulting, LLC. This meeting will serve to orient participants to the participatory design workshop goals and process.

May 2024

Workshop Pre-Work

Participants will complete **30 minutes or less** of pre-work that will optimize time during the participatory design workshop itself. The exact pre-work tasks are to be determined but may include reviewing a high-level summary of project findings thus far, reviewing foundational or draft documents, and/or completing a survey.

May 2024

Participatory Design Workshop

Participants will participate in a **90-minute** participatory design workshop with 2-3 other LHDs facilitated by Kahuina Consulting, LLC. Participants will provide feedback on a surveillance data to action pathway and recommendations to bolster data to action efforts.
