On behalf of the National Association of County and City Health Officials (NACCHO), I write in support of the nomination of John M. He has extensive experience at the local and national level working in infectious disease, vaccine research, and as a member of several immunization workgroups/advisory committees. In his work at the national level at the Centers for Disease Control and Prevention (CDC), he oversaw HPV vaccine scientific efforts, the integration of STI and immunization services, and served as a member of the ACIP Steering Committee and the ACIP HPV Vaccine Workgroup. Dr. Douglas' local and national level public health experience, substantial work in vaccine research, and proven service in expert and advisory capacities highlights his ability to address the evolving field of immunization at various levels. The breadth and depth of his experience make him an ideal candidate for this position.


