Project Overview



• Overview

- NACCHO will provide funding and technical assistance around 7 Tribal health departments and 10 LHDs to adapt and implement Project Firstline tools and resources.
- Goal
 - Strengthen capacity in healthcare infection prevention and control (IPC) by piloting and adapting tools and best practices using Project Firstline resources.
- Funding
 - NACCHO will issue two awards depending on the category of engagement:
 - Awards up to \$150,000 for health departments who select to complete ONLY required activities
 - Awards up to \$200,000 for health departments who select to complete required AND supplemental activities

Required Project Activities



Complete an initial assessment provided by NACCHO to identify IPC related training needs;

Participate in monthly calls with NACCHO to monitor progress, facilitate peer-exchange, and provide technical assistance;

Identify, adapt and implement at least four existing Project Firstline tools and resources as part of specific outreach, education, or training activities for healthcare facilities in the jurisdiction or locality;

Schedule a site visit for NACCHO to meet project staff and review the work plan and progress (Tribal health departments ONLY);

Participate in evaluation related activities to track and measure progress towards expressed outcomes;

Attend the end of the project in-person meeting; and

Submit an end-of-project report.

Supplemental Project Activities



Develop (i.e., not just implement or adapt) specific IPC outreach, education, and training activities for healthcare facilities in the jurisdiction or locality;

Partner with an IHS Area Office, local or state health department and develop a collaborative strategic plan to address gaps and improve IPC in the jurisdiction or locality; and

Facilitate a training session (quick hit session) during the end of the project in-person meeting.

- Application Components
 - Jurisdictional Information
 - Information about your organization & description of your jurisdiction
 - Project Narrative
 - Description of project goals and anticipated impact
 - Description of capacity to implement approach
 - Description of willingness and capacity to establish & leverage partnerships
 - Description of this work on health equity in the jurisdiction

Application Process cont.



- Budget Justification and Narrative
- Additional Requirements (Supporting Documentation)
 - Vendor Information Form
 - Certification of Non-Debarment
 - Proof of SAMS registration
 - W-9
 - FFATA Form

Selection Criteria



Applications for this project will be reviewed and scored based on the following criteria.

Criteria	Weight
Jurisdictional need	25%
Capacity to implement the project	30%
Strategy and approach (Description of project activities)	40%
Health Equity	5%
