Site Spotlight: Tri County Mediation

Located on the Lower Eastern Shore of Maryland and representing the three counties of Wicomico, Worcester, and Somerset, Tri Community Mediation (TCM) is a community-based organization dedicated to supporting people and communities through mediation and conflict resolution services. Probing through the demographics of their localities, TCM recruits members of diverse and critical communities to train as volunteer mediators who often receive referrals and respond to areas of social need at no cost.

One critical population TCM serves and collaborates with is the local Haitian community, many comprised of newly arrived families and individuals who face various sociopolitical and economic challenges abroad and here in the United States. In light of the ongoing COVID-19 pandemic, TCM fosters and nurtures relationships with other community organizations, including Haitian Development Center of Delmarva and Rebirth, Inc., as well as Migrant Clinicians Network and Wicomico County Health Department to connect with Haitian communities to identify, understand, and address COVID-19 challenges including misunderstandings, congregated living and working settings, health education, and other needs that may exacerbate the burden and impacts COVID-19 is leaving these communities with. Through programs like one-stop-shop events in collaboration with libraries, food banks, partners, and volunteer community mediators, TCM connects communities with resources and social services related to housing, employment, childcare, school registration, utility assistance, health insurance, and various other challenges for vulnerable populations, especially people facing issues of documentation, discrimination, neglect, stable housing, and more. Through partnership building and elevating involvement, leadership, and contribution from critical populations like local Haitian communities, TCM is a part of a growing network that leverages collaboration and connection with community leaders through human-centered approaches to deepen relationships, trust, and access to more significant resources for populations most in need amidst the disproportionate impacts of COVID-19 and continuous health and systemic issues faced by many.

NEW Funding Opportunity: Equipping Local Health Departments to Build COVID-19 Vaccine Confidence

With support from the CDC, NACCHO is pleased to offer a funding opportunity that will support LHDs to improve COVID-19 vaccine confidence and address misinformation at the community level in partnership with local trusted community messengers. NACCHO will select up to twenty (20) local and/or tribal health departments, providing each up to \$75,000 for this funding opportunity. This funding opportunity is open to LHDs with an interest or clearly identified need to promote COVID-19 vaccine confidence and mitigate the impact of vaccine misinformation among priority populations disproportionately impacted by COVID-19 disease and complications, as well as those with low COVID-19 vaccination rates. NEW Funding Opportunity: Printing Mini-Grants Funded by NRC-RIM

Common barriers to using NRC-RIM vaccine campaign materials are time and cost. Now, a new mini-grant program, provided by University of Minnesota, can help overcome both obstacles. Local health departments, community organizations, and other small non-profits can now request printed materials from NRC-RIM. Funding is limited, and requests will be processed in the order they are received. Please allow approximately two weeks for delivery. If we are unable to fund your request, NRC-RIM will work with you on ideas to support your work through non-printed materials, like social media campaigns.

NRC-RIM newest conversation guide explains why it is important to get tested for COVID-19 and how to stay safe regardless of the results. This is the latest in NRC-RIM growing collection of conversation guides, which includes topics such as boosters, breakthrough infections, and immigration and COVID-19. Health Equity Resources and News

National Equity Atlas Fellows Program Announced

The National Equity Atlas research partnership, a collaboration between PolicyLink and the USC Equity Research Institute, is seeking applicants for its 2022-2023 class of National Equity Atlas Fellows. This 12-month fellowship program is designed to support community-led efforts to advance racial and economic equity by building the capacity of people of color working in grassroots organizations to analyze, visualize, and use deeply disaggregated data in support of equity campaigns.

HD4NYC and NYC Healthy Partner to Advance Policy-Relevant Research in Health Equity

Health Data for New York City (HD4NYC), a unique partnership between The New York Academy of Medicine and the NYC Health Department to advance policy-relevant research to promote health equity, has released its initial research publications in the Journal of Urban Health. The papers address important systemic factors that influence health, including the criminal legal system, tobacco control, maternal healthcare, and socioenvironmental contributors to childhood asthma.

From the Field: Research, Policy, and Project Updates

Recent Report from COVID-19 State of Vaccine Confidence Notes that Social Media Users Pointed out Discrepancies in CDCs Quarantine Guidance

The COVID-19 State of Vaccine Confidence Insights Report emphasizes major themes influencing COVID-19 vaccine hesitancy and uptake, categorized by their level and type of threat to vaccine confidence, degree of spread, and directionality. The recent report noted that consumers and news outlets had pressing questions and concerns about the SARS-CoV-2 Omicron variant. Most notably, social media users pointed out discrepancies in CDC guidance and quarantine practices. Those surveyed also questioned whether people could donate blood or blood plasma after receiving the vaccine. Visit the link above to read other major themes from this report.
