<b>20</b>	<b>Dr Julie Ware, MD, MPH, IBCLC <i>Associate Professor of Pediatrics</i> Cincinnati Children’s Hospital Medical Center Jamaica Gilliam Hamilton County Public Health</b>	Overview of the Implementing the CoC Blueprint project and partnership with the health department in Hamilton county, especially the following blueprint strategies: Workflow/referral systems (warm hand offs), Community Lactation Care coordinator (and the CBA work), screening tool/triage system for rapid referrals to community support, and Consistent messaging. These include developing chest/breastfeeding education for the prenatal and postnatal setting and plan dissemination to all levels of providers, to “speak with one voice” to help chest/breastfeeding families be successful in their feeding plans. In addition, the SWOBC has developed a breastfeeding resource guide, and work toward universal dissemination from key contacts identified. With the collaboration of area birth hospitals involved in CCHMC quality improvement work, we will develop a referral process for families at risk of chest/breastfeeding difficulties. We will use quality improvement methodology, to ensure that developed processes can be successful, first on a small scale
